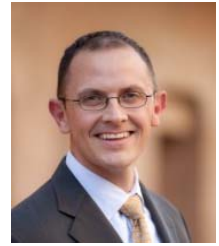

Brad Petersen has successfully represented clients in product liability, health care, and commercial litigation for more than 17 years. He has served as lead counsel and has first chair trial experience in the defense of product manufacturers in wrongful death, personal injury, and program/target-type cases that resulted in defense verdicts for his clients in difficult jurisdictions. Brad has served and continues to serve on national and regional counsel defense programs concerning specific products and claims. In addition to trial and litigation work, he counsels clients to assess and develop warnings and instructions for products and product manuals. Brad also has advised manufacturers and distributors on regulatory issues, including compliance with and responses to rulemaking and proposed rulemaking by the National Highway Traffic Safety Administration (NHTSA) and the Consumer Product Safety Commission (CPSC).

Representative experiences include litigation, trial work, or jury projects in the following areas:

- Automotive product defense – rollover, collision, crashworthiness, tire, fire, asbestos, and recall cases.
- Marine product defense – engine, ejection, prop guard, crashworthiness, carbon monoxide exposure, and fire cases.
- Medical device and pharmaceutical defense – latex glove, surgical instrument, skin treatment and hair removal systems, inferior vena cava filter, anesthetic contamination, and anesthetic drug for pain pump cases.
- Consumer product defense – ventilation fan, small motor, aerosol can, battery, coffee maker, ladder, machine washer, window guard, HVAC, and water filter cases.
- Health care defense – alleged medical malpractice cases involving hospitals.
- Commercial litigation and insurance defense – intellectual property, trade secret, class action, breach of contract, breach of warranty, tortious interference, dram shop, premises liability, trucking, commercial vehicle, automobile, motorcycle, and industrial equipment cases.

Brad's trials and resolved cases include:

Castillo v. Ford Motor Company – As co-lead trial counsel, Brad successfully defended Ford in a wrongful death case involving a rollover crash and claims related to occupant protection and ejection mitigation. After a two-week trial in Crystal City, Zavala County, Texas, the jury returned a defense verdict in just three hours.

Customer v. HVAC Manufacturer – As lead counsel, Brad successfully defended a large HVAC manufacturer against warranty claims that its unit was defective, resulting in a defense verdict and judgment for attorney fees and costs.

Patient v. Medical Device Manufacturer – As Arizona counsel, Brad worked with national counsel to successfully defend a large medical device manufacturer in the first bellwether trial of a device that fractured in the patient. After a month-long trial in Maricopa County, Arizona, the jury returned a defense verdict, which was identified as a “Significant Defense Verdict” in *Arizona Attorney's* 2012 Arizona Civil Verdicts review.

Cambron v. Ford Motor Company – As trial counsel, Brad successfully defended Ford in a catastrophic injury case involving a rollover crash and a claim that the truck was defective because it lacked electronic stability control (ESC). After a six-week trial in Los Angeles, California, the jury returned a defense verdict. The court of appeals upheld the defense verdict as to ESC but reversed the dismissal of another claim.

Mendoza v. Ford Motor Company – As lead trial counsel, Brad successfully defended Ford in a wrongful death and catastrophic injury case that involved a rollover crash and claims that the Ford Expedition's roof and seatbelt were defective. After a 3½-week trial in Maricopa County, Arizona, the jury returned a defense verdict in just two hours. *Mendoza* was identified as a “Significant Defense Verdict” in *Arizona Attorney's* 2007 Arizona Civil Verdicts review.

State Farm v. Broan-NuTone, L.L.C. – As lead counsel, Brad successfully defended Broan in product liability case involving a fire based on the Plaintiff's failure to preserve the fire scene. Broan moved for sanctions and the United States District Court of Arizona dismissed the case with prejudice. *See State Farm Fire & Casualty Co. v. Broan Mfg. Co.*, 523 F. Supp. 2d 992 (D. Ariz. 2007).

Canales v. Ford Motor Company – As co-lead trial counsel, Brad successfully defended Ford in a wrongful death case involving a rollover crash and a claim that the driver lost control due to an alleged defect. After a two-week trial in Hidalgo County, Texas, the jury returned a defense verdict in less than one hour.
